DO HEREBY RESOLVE:

WHEREAS:

- A. The Council of Wasauksing First Nation (the "Council") enacted the Wasauksing First Nation Temporary Emergency Response Law (the "Temporary Emergency Response Law") and the Temporary Emergency Response Law Amending Law;
- B. The Council subsequently has enacted the Wasauksing First Nation Emergency Response Law, which it has enacted on the 21st day of July, 2020 (the "Emergency Response Law");
- C. The Council determined, in accordance with the Temporary Emergency Response Law, that a state of emergency existed on Wasauksing First Nation reserve lands ("Wasauksing Lands") as a result of the imminent and serious threat to human health caused by the COVID-19 global pandemic (the "Pandemic");
- D. The Council declared a State of Emergency under the Temporary Emergency Response Law on March 24, 2020, and continued and renewed this State of Emergency on June 10, 2020 (the "First State of Emergency");
- E. The Council subsequently revoked and replaced the First State of Emergency with a State of Emergency declared under the Emergency Response Law, dated the 21st day of July, 2020 (the "State of Emergency");
- F. The State of Emergency expires at the end of 90 days unless the declaration is previously revoked, continued or renewed by Council, in accordance with section 3.4 of the Emergency Response Law; and
- G. The Council has determined, in light of the continuing Pandemic and its ongoing threat to human health, that it is in the best interests of Wasauksing First Nation to continue and renew the State of Emergency in accordance with the Emergency Response Law,
